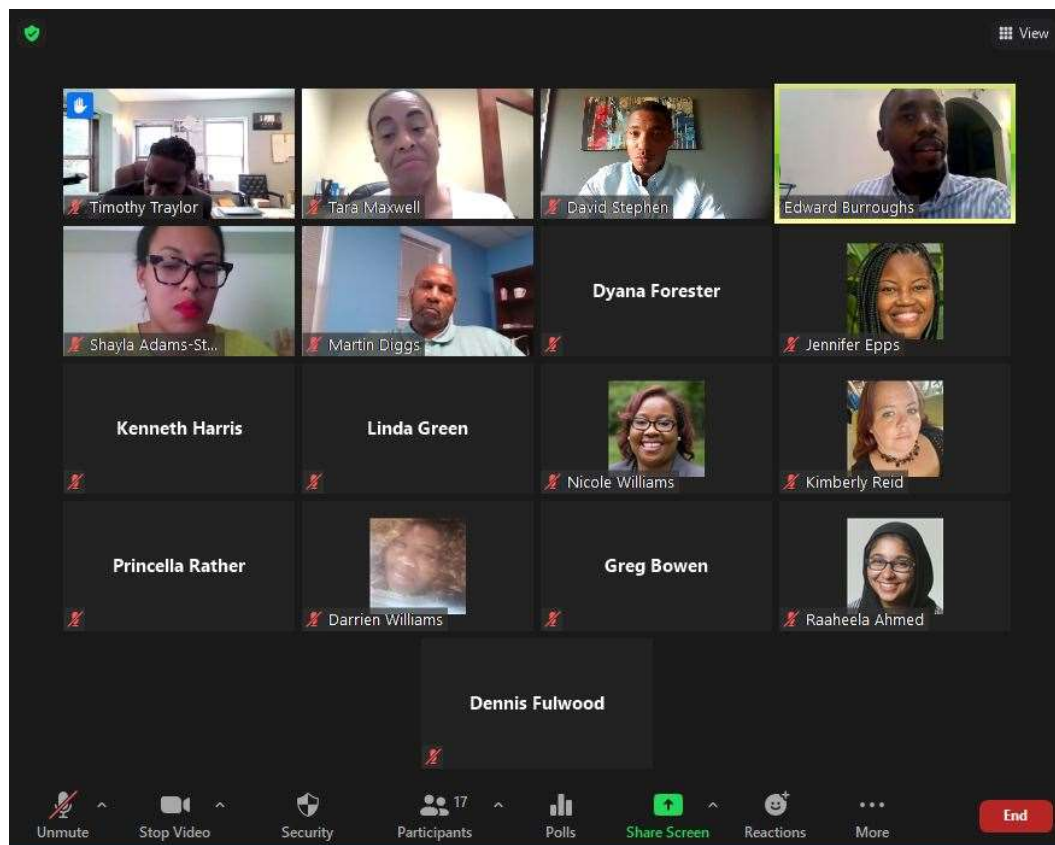

COVID-19 / EMERGENCY ASSISTANCE

CSA has received a \$21,000 grant from the Greater Washington Community Foundation to provide food assistance to workers facing hardship due to no fault of their own **and** who live within the following zip codes: 20001, 20004, 20005, 20009, 20010, and 20018.

CSA's executive director conducted outreach to locals largely impacted by the economic fallout of COVID 19 to get a sense of the numbers of workers who live in the designated zip codes.

This grant will only provide a small portion of workers with food assistance.

Upon receipt of the funding, the executive director will reach out to locals with members hit hard by COVID-19 with further instructions on this grant.

BUILDING FUTURES CONSTRUCTION PRE-APPRENTICESHIP PROGRAM

Building Futures' DOES-funded cohort graduated a total of 14 DC residents, a group of veterans and older youth 19-24 with an interest in launching a career in the building and construction trades. We partnered with Helmets to Hardhats, the Insulators Local 24, Piledrivers, Sheet Metal Workers, and Heavy Equipment Operators Local 77.

The students received pre-apprenticeship training based on the AFL-CIO sponsored Multicraft Curriculum or MC3 and a safety certifications packet that includes OSHA 10, Flagger Safety and Traffic Control, CPR, First Aid and AED, and Scaffold User Training. In addition to the training curriculum, students receive job counseling and individualized case management and referrals to other programs in the city to address any challenges to employment. This combination of intensive worker-centered industry training, safety certifications, personalized job counseling and case management has become a model of practice for other organizations interested in scaling it up such as Job Corps and re-entry programs.

Building Futures is currently running in hybrid mode with live online learning, self-learning and in-person learning for some of the certifications and hands on experience. When conducting training in-person we have prioritized safety and put preventative measures in place to protect our staff, instructors, consultants and students in alignment with the CDC and the District of Columbia COVID-19 guidelines for community organizations, churches and schools.

CLAIMANT ADVOCACY PROGRAM

Tonya Love, Program Director; Lolita Martin, Attorney

The Claimant Advocacy Program's overall objective is to advise and represent claimants with DC unemployment benefits who have a scheduled hearing before the Office of Administrative Hearings.

Additional tasks:

- Discussed existing issues with DOES regarding regular UI, PUA, PUEC and FPUC.
- Assisted claimants that were willing to provide written or oral testimony before the DC City Council's DOES Performance Oversight Hearing
- Check-ins with other stakeholders on issues on a broader level that affect unemployment benefits.
- Suggest and connect UI claimants with other resources, when/if needed.

Summary:

1. Invoiced for the month of September in the amount of 58K and exhausted the maximum invoice amount for the year. From March 2020 until September 2020, CAP has been the primary POC for questions related to DC unemployment claims and have advised and/or represented more than 500 individuals.
2. CAP continues to assisted hundreds of union and non-union members in accessing the UI system in DC, with multiple emails, calls and texts to POCs at DOES. We have assisted, escalated or resolved 8 union members' claims during the months of September, which are unbilled hours.
3. As for billed hours in September: (3) 32BJ, (3) SEIU 722, (1) WTU 6, (1) UFCW 400, (3) UNITE HERE 25 and (1) UNITE HERE 23 members were represented.
4. Proposed a streamlined method of escalations. Through continued discussions with DOES to reduce the misinformation regarding Pandemic Unemployment Assistance (PUA) applications as well as the PUA process and backlog, DOES proposed a revised method of sending CAP escalations and receiving timely responses, which began in Mid-October.
5. Continued the bi-weekly conference calls with the Commission Task Force of the DC Office of Administrative Hearings.
