#### PRESIDENT'S REPORT: MARCH 2021

**Dyana Forester** 

This month we finalized 2019's audit and worked to update organizational policies to reflect recommendations. In addition to continuing the work to clarify the infrastructure question regarding CAP

With the announcement of the departure of Sonte DuCote, Ex Director of CSA, I worked with the board and staff to develop a hiring and transition plan for CSA

Worked with our affiliates to appoint the following labor representatives to DC Boards

Public Employee Relation Board- Renee Bowser
Workforce Investment Board - Amelia Kalant, Director of STEP UNITE HERE 23
William "BJ" Paige, Director for the Metro Area, Building Trades

**Sine Die** – Worked with our affiliates to make sure priority legislation was successfully passed-MD Essential Workers and a few smaller bills that were specific to an industry.

Met with MD State Delegates to debrief session and with DC Council Members to discuss legislative priorities

Participated in DC Vote events for Statehood and presented at Prince George's County Pro Act Panel

Awarded DC Woman of Excellence Award



#### **Claimant Advocacy Program Report**

The Claimant Advocacy Program's overall objective is to advise and represent claimants who have Unemployment Compensation Appeals hearings before the District of Columbia Office of Administrative Hearings.

#### Additional tasks:

- CAP participated in the weekly stakeholder's meeting with the Office of Administrative Hearings, advocacy groups, and others concerning unemployment issues and case management.
- CAP followed up with DOES to discuss the approval of the contractual adjustments.
- CAP met with DOES regarding the computer upgrades to gain information regarding expectations in the future.
- In addition to the escalation process for CAP/DOES to address union members' issues
  with wage credits issues, CAP met with CM staff (Councilmember White) to see if we can
  gain assistance in MD and VA. CAP also received feedback from DOES regarding how
  they can provide further assistance with interstate claims.

#### Summary:

- 1. Closed out the former CAP/DOES contract.
- 2. CAP began work under the new contract in March. We submitted the first invoice for March in the amount of \$44K. We are awaiting a mid-year adjustment following the agency's review of the proposed changes under the new contract.
- 3. CAP continues to assist union and non-union members in accessing the UI system in DC, with multiple emails, calls, and texts to POCs at DOES. We are still working with individuals with interstate claims and extension of claims issues. These are issues affecting/impacting members of IASTE 22, UNITE HERE 25, and 32BJ members.

#### **DUCOTE STEPPING DOWN AS CSA EXECUTIVE DIRECTOR**



After serving as Executive Director for the Metro Washington Council's Community Services Agency for nearly four years, Sonté DuCote is stepping down. "It's been a real privilege to work with DC-area locals facing layoffs, strikes, government shutdowns and now an extraordinary pandemic." Under DuCote's leadership CSA has helped thousands of workers stay in their homes and keep food on their tables, secured a \$300k federal grant to increase the number of women in the local construction industry, partnered with community-based organizations to expand CSA's reach into vulnerable communities and streamlined administrative processes. "I want to thank every local, allied organization, foundation and individual donor for your support," DuCote said. "You and CSA will always have a special place in my heart, and it

is my hope that we stay connected." DuCote will remain on board through May 21st to ensure a smooth transition.

# BUILDING FUTURES CONSTRUCTION PREAPPRENTICESHIP PROGRAM

Last month's United Planning
Organization UPO CSBG-funded
program recruited, trained and
graduated 20 students. Our team is
working with them to ensure they meet
their financial, general wellbeing and
career goals. Two of our graduates
completed LiUNA training and are

awaiting placement into well-paying jobs with benefits to support themselves and their families, two have have joined SMART Local 100 apprenticeship and three more graduates joined the Piledrivers apprenticeship and are working at the Wharf.



CSA received a small grant from the Greater Washington Community Foundation's Joshua Fund to provide literacy support and financial assistance through the Building Futures Program in Census Track CT47. The program partnered with Literacy Volunteers of America (LVA) to conduct literacy support to five students throughout five weeks, which resulted in a great learning experience for the targeted students. These students, who also lost their jobs

as a result of COVID-19, are receiving financial assistance from the Joshua Fund.

Building Futures staff participated in three key speaking engagements this past month:

- DC Workforce Investment Council (WIC) to present Building Futures Best Practices in the pre-apprenticeship category
- ANC 6D Public Meeting to present program information and launch recruitment in the area
- DOES Office of Apprenticeship, Information and Training (OAIT) to present solutions and challenges around the issues of Disparities, Equality, and Inclusion (DEI) to staff, union registered apprenticeships and employer sponsors' quarterly meeting. Building Futures' March cohort reached a 50% of women graduates as opposed to the 4.2% of women currently enrolled in DC registered apprenticeship programs.

Building Futures prepares DC residents to join the workforce with the AFL-CIO sponsored MC3 curriculum which includes an orientation to the construction industry, apprenticeships and jobs, rights and responsibilities in the workplace, blueprint reading, math, job readiness, case management, discrimination and harassment at work, and industry-recognized certifications such as OSHA 10, Flagger Safety, CPR, Firsts Aid and AED, and Scaffold User. Our graduates have been vetted and are ready for work, they are drug-free, conscious about safety and reliable. Other activities: collaborated with AFL-CIO on analysis of voter suppression laws around the country. In response to the passage of Georgia's 2021 voter suppression laws, last March, President Richard Trumka stated, "Georgia Republicans have shown their true colors. The rushed passage of S.B. 202 is no less than a full-blown assault on Georgians' right to vote, one aimed at silencing working people of color across the state. Brian Kemp is openly dragging Georgia's elections back to the Jim Crow era, from making it harder to register to vote to criminalize those who bring water to voters waiting at the polls."

Unfortunately, the effort to suppress votes goes further than Georgia. In this state-by-state overview compiled by the AFL-CIO (available on request; email <a href="mailto:dstephen@dclabor.org">dstephen@dclabor.org</a>), findings show that as of April 6, 2021, Republican legislators have introduced **361 restrictive voting bills** in **47 states**. These restrictive bills aim at Voter Identification Requirements, Vote-By-Mail, early voting, proof of citizenship, same-day registration, election certification, and voter roll purges.


#### For the People Act

To address some of these issues, Congress introduced HR 1, The For the People Act which passed on March 3, 2021. The bill has advanced to the Senate but does not have filibuster-proof support. **Announcement** – Elise Bryant (CLUW) – invited to join Wednesday, March 24, 2021 to celebrate the 47<sup>th</sup> anniversary of the Coalition of Labor Union Women.

#### Approval of Minutes

Call the Question – to accept the minutes as presented Motions Passes - unanimously

#### **President's Report:** presented by President Forester

- Will be combining the program reports under the umbrella of the President's report because of the tight agenda for today; no actions need to be taken
- Focusing on administrative work; making sure the audit is done and finances are in place; dealing with outstanding arrear accounts; have had committee meetings to address some financial challenges; adhering that all administrative processes and procedures are up to date to include constitutional changes where necessary and appropriate to reflect organizational changes; planning for a 2021 constitutional convention
- Will have a per capita system and will be sending out information to update the affiliates; looking to put in place a new system for handling per capita payments because been having trouble getting into the AFL-CIO system; want a more sufficient, transparent process in place
- Gearing up for the DC budget fight; making sure that the MWC is keeping track of cuts, so having meetings with the public sector unions as well as the education unions
- MWC appoints individuals to different boards and commissions; have good candidates in the mix
- David Stephen update on legislative work Getting Real about COVID-19 Vaccination Forum
  - ✓ Djawa Hall Maryland Essential Worker Protection Act working through a subcommittee in the MD legislature and has been taking a beating, have replaced the clean bill and certain tenants therein with a new bill; need to hear from labor and the workers; hearing a lot from the business community; workers are being forgotten; link to tweet the legislature; essential worker Wednesdays
  - ✓ Korey Hartwich Medical Debt Protection Act shared a report last year that hospitals sued patients for monies owed; over a ten year period 145,000

Marylanders were sued for medical expenses; launched a medical debt reform bill to try and put guardrails in place; 1199, 32BJ, IBEW26, IBEW24, MWC, ATU689 were supportive; the bill that looks like it is going to pass is watered down but there are a lot of great consumer protections in place; end medical debt coalition

#### Financial Report: presented by Eric Bunn

#### <u>Financial Statement</u> (as of February 28, 2021)

- CSA owes MWC about \$52,000, may have been reduced some; CSA paid almost \$20,000 in February; the actual number owed is \$30,000
- addressing the doubtful accounts regarding how to deal with this matter have a plan how to facilitate it going forward
- total assets = \$1,635,000
- accounts payable = \$83,000
- current liabilities about \$395,000
- total liability, unrestricted net assets and net revenue = \$1,635,413

- per capita \$145,000 CAP 83,000 Fundraising 10,000 (will be placed on accrual accounting for audit purpose, was received in 2020)

**Announcement** – President Forester – April 1<sup>st</sup>, the payroll protection loans were extended to unions and Bank of Labor will be doing an information session for unions that are experiencing layoffs or other financial hardship

#### Affiliate Updates

- 1. **Eric Bunn** –AFGE has been attacked heavily by the Trump administration which has had a significant impact on their ability to represent their membership; received guidance last week about the rescission of the Trump executive orders; refreshing to go back to the table to negotiate for their members
- 2. **Laronda Gamble** (AFGE Local 12) Senate confirmed Marty Walsh as the Secretary of Labor; AFGE is looking for MWC to stand in solidarity as they look to reopen and negotiate their contract; may need assistance
- 3. **Marcus Wilson** with the COVID-19 Relief Act, is there somewhere to look to find the breakdown of how the monies are distributed; reach out to David Stephen and he will assist with getting that info; any specific legislative questions that require research
- 4. Robin Burns (DCNA) school Nurse with DCPS and DC Health has decided that the school Nurses do symptomatic testing and asymptomatic testing for COVID-19; Children School Services, the employer, is refusing to give hazard pay and refusing to randomly test the Nurses; will meet with members tomorrow and members will be ready to stand together to take action against this disparity; school procedures and guidelines
- 5. **Robert Hollingsworth** (Council 20) was able to get shots set aside for sanitation workers, up to 300-500 sanitation workers now have the ability to get vaccinated
- 6. **Donna Brockington** the Metro DC CLUW is doing a virtual program for Women's History Month; will be showing On the Basis of Sex; will be in Union Cities; program is on Thursday and there will be opening remarks and statements by national CLUW President Elise Bryant and closing remarks and discussion by Tyra McClelland, AFGE National Women's Action Coordinator for district 14
- 7. Roxie Meija thank you for all calls to Senator Warner to sponsor the PRO Act; going to start doing mornings with Mark Warner and go to his house calling for him to co-sponsor the PRO Act and will take place in Alexandria; will take place every week; still need five Senators to co-sign
- 8. **Theresa** (PGCEA) speaking about Sonte DuCote; looking for more board members for Community Crisis Services (in Prince Georges County), that does suicide prevention hotline (covers whole Washington Metropolitan area), domestic violence assistance, and has three homeless shelters they aid; looking for four to six new board members

- 9. **Dena Briscoe** (American Postal Workers Union) impressed and excited with the Biden nominees for the NLRB; worked with two of the gentlemen nominated Roman and Anton Hodge
- 10. **Afnan Adam** (CLUW Communications Associate) 47<sup>th</sup> anniversary event; only national organization for union women

**Announcement** – President Forester – Kaye Blotto appointed to the NLRB
