#### Claimant Advocacy Program Report – October 2022

The Claimant Advocacy Program's overall objective is to advise and represent claimants with Unemployment Compensation Appeals hearings before the District of Columbia Office of Administrative Hearings. In addition, the program offers public relations opportunities for the MWC to former union and non-union employees as well as city agencies.

- We continued our regular check-ins with stakeholders, including DOL, to assist in resolving UI issues on a broader level.
- CAP participated in the stakeholder's meeting with the Office of Administrative Hearings, advocacy groups, and others concerning unemployment issues and case management.
- CAP assisted the MWC with advice or observations regarding other issues related to job loss, unemployment trends, and legislative proposals in the metropolitan area.

#### Summary:

- 1. CAP continues to meet our responsibilities under the current contract with DOES and invoicing for services performed.
- 2. CAP continues to assist claimants in accessing the UI system in DC with emails, calls, and texts to POCs at DOES. We also continue to help individuals with interstate claims (MD/VA) and extension of claims issues.
- 3. Former union members equate our pro bono unemployment claim assistance as an extension of their union affiliation. We often work with shop stewards or business agents to gain insight into the cause of unemployment, including documentation and witnesses. Moreover, claimants have the security of knowing that, in addition to their union grievance process, the union is working with the MWC via CAP, providing advice or representation regarding their contested UI claim.

#### Maryland AFL-CIO Convention

The 33rd Biennial Maryland AFL-CIO Convention took place on October 13th through October 15th. Several resolutions and constitutional amendments were made. In addition, Gubernatorial Nominee Wes Moore and Lt. Gubernatorial Nominee Aruna Miller came to meet with affiliates, along with appearances from Senator Chris Van Hollen and Rep. Jamie Raskin. President Dyana Forester nominated the new and returning members to the Maryland Executive Board.

#### Report Conclusion

The COPE committee continues to add capacity to Metro Washington Council affiliates by ensuring members in Maryland and District of Columbia are informed about the upcoming elections and labor endorsed candidates. In addition, affiliates are beginning to discuss legislative priorities at the county and state level. It is the recommendation of the COPE department that affiliates begin to take an internal audit about what their legislative priorities are for the upcoming year.

#### **CSA Executive Director Report**

October 22. 2022

During this reporting period, in partnership with the community volunteers/nonprofits, and board members, CSA has accomplished the following in support of its goals.

# I. Program: Building Futures Pre-Apprenticeship Construction Program, Summer Cohorts

During this reporting period, CSA hosted two (2) Pre-Apprenticeships programs funded by the United Planning Organization (UPO) and the DC Department of Employment Security. CSA recruited seventeen (17) men and women who were qualified DC residents in the UPO-funded Building Futures Pre-Apprenticeship Program. The Building Futures Pre-Apprenticeship Program, ages 18 – 24, DOES-funded cohort, recruited eleven (11) men and woman and provided students a working wage of \$16.10 per hour, up to 25 hours per week.

A total of twenty-eight (28) participants received industry-recognized certifications including OSHA 10, CPR, First aid and AED, Flagger Safety Training. CSA offered the Building Futures program at the Cement Masons Apprenticeship Local 891 site. Both cohorts had a 100% success rate and graduated a total of twenty-eight students from the Summer 22' cohorts. Within the six weeks of classes, both cohorts completed training on interview skills, job placement skills, flagger certification, financial literacy, hands-on experience, blueprint reading, and scaffold building.

#### Employment Placements: thirteen students

Apprenticeship Placements: five students were recruited by the Plumbers, Local 5 as "Helpers" with the understanding they will gain direct entry into the apprenticeship program after completing the Helpers program.

#### II. Resource Development

- Grant Award: The 2023 United Planning Organization (UPO) Grant award to support the Building Futures Pre-Apprenticeship Program in the amount of \$250,000.
- Grant Award: Department of Employment Services (DOES) grant award to support the Building Futures Program, \$3,863.00 per participant - October 1, 2022, through September 30, 2023. DOES is working to modify the CSA contract to include language for an upfront payment for services (as opposed to payment 10 days into a class).

- Grant Award: Shared Fund Grant \$15,000
- In Progress: United Way of the National Capital Area, Due November 4, 2022

#### III. Fundraising Event Results:
