PRESIDENT'S REPORT JUNE 28, 2022

Over the past month, the focus has been to work with our COPEs Chairs and Political & Legislative Director to develop and implement a plan to engage our union members in the upcoming Primary Elections in DC & MD.

In the area of Legislation, we have supported the following Executive Committees formed by Mayor Bowser. Unions representing specific areas of workers were appointed to serve on the committees by the President.

- Build Back Better
- Health Committee

Supporting our organizational oversight, we have finalized our 2020 Audit, convened a mid-year assessment, and developed a work plan for the remainder of 2022.

MISSION

Serving as a unified voice for workers' rights in the Metropolitan area by representing and promoting the interest of Labor unions and, ultimately, all workers. Committed to providing resources and capacity to strengthen our affiliated union's ability to collectively bargain, represent their members, and grow the labor movement.

Our local economy creates employment opportunities that provide workers with fair and just wages, benefits, the ability to retire, and a voice on the job through collective bargaining, ultimately allowing our community to work and thrive without further displacement and disfranchisement.

CURRENT STATE

The Metropolitan Washington Council, AFL-CIO has a history that evolved around long-serving leadership and staff. In 2015, decisions were made that shifted the organizational structure, and since then, there have been three different Presidents, after decades of just one. In addition, due to the changes in organizational structure and fluxes in leadership, program areas have operated independently and with little strategic oversight. It is essential that our program areas remain focused on the mission of the organization.

In 2020, when we returned to a full-time President, the immediate priority was to stabilize the organizational structure and finances and provide direction to program areas.

Now two years later, we have accomplished our goal of stabilizing the organization and successfully positioned the Metropolitan Washington Council at the center of regional politics, putting us in position to be a valuable resource to all our affiliates.

Political & Legislative

On Saturday, labor showed up in full force at the Poor People's Campaign Moral March on Washington. Members from 1199SEIU and SEIU VA 512 marched in solidarity with the millions of working people across the United States that are fighting for a better future. CSA Executive Director Report

During this reporting period, in partnership with the community volunteers/nonprofits, board members have accomplished the following in support of CSA's goals.

Accomplishments: April 2022 – June 27, 2022

On June 23, 2022, Community Services Agency received the 2022 United Planning Organization (UPO) Partnership Recognition Award. It was an honor to be presented with this award and the opportunity to meet community members. UPO is one of CSA's significant funders for the Building Futures Program.

- 3) Nicholas Cummings, Director of Baltimore DC Metro Building Trades, was assigned to CSA, Building Futures program to provide program support and resources.
- 4) Stephen Courtien recommended Wallace Beal to identify a math teacher, for the Building Futures Program. In progress

Spring Cohort 2022 - Building Future Pre-Apprenticeship Program Graduation Ceremony

- On May 26, 2022, thirty-nine (39) students successfully graduated from the CSA's Building Future, Pre-Apprenticeship Program (2). The Building Futures Graduation Ceremony was held at the DC Dream Center, 2826 Q Street, SE, Washington, DC 20020, at 11:00 a.m. The Department of Employment Services (DOES) directors, United Planning Organization (UPO) COO, and UPO Program Manager attended the graduation program.
- To measure our program's success and identify areas of improvement we conducted a pre-post evaluation and a mid-year program review with our students and staff.
- Summer Cohort 2022 Building Futures Pre-Apprenticeship Program, scheduled for July 11, 2022. Student recruitment is in progress.

Claimant Advocacy Program Report – June 27, 2022

The Claimant Advocacy Program's overall objective is to advise and represent claimants with Unemployment Compensation Appeals hearings before the District of Columbia Office of Administrative Hearings.

Monthly tasks:

- We represented, advised or assisted several former members of MWC affiliates, that includes SEIU 722, Unite HERE Local 25, and 32BJ.
- We continue to assist claimants with their initial filings, weekly claim reporting, and re-opening of claims. We also mediated and advised claimants regarding lingering issues under the expired federal pandemic programs, fraudulent claims, and overpayments.
- We continued our regular check-ins with stakeholders, including DOL, to assist in resolving UI issues on a broader level.
- CAP participated in the weekly stakeholder's meeting with the Office of Administrative Hearings, advocacy groups, and others concerning unemployment issues and case management.

Summary:

- 1. CAP continued meeting our responsibilities under the current contract with DOES and invoicing for services performed.
- 2. CAP continues to assist claimants in accessing the UI system in DC with multiple emails, calls, and texts to POCs at DOES. We also continue to help individuals with interstate claims (MD/VA) and extension of claims issues.
- 3. The Claimant Advocacy Program, CAP, is an extension of union affiliation with the Metropolitan Washington Council, MWC. CAP works with shop stewards to understand and prevent wrongful termination of union members. CAP and affiliated unions have the advantage of sharing factual information that otherwise would not have been revealed but for the Unemployment Compensation Appeals Process. Facts and information gathered and discovered by CAP attorneys have been instrumental in reinstating union members' employment and receiving back pay. Union members whose unions are affiliated with MWC have the extra added security of knowing that they have access to attorneys with over 45 years of combined legal experience who will fight to ensure they receive income while grieving their termination, unpaid suspension, and/or seeking other employment. Whether or not a termination or unpaid suspension is grieved, affiliated union members may still avail themselves of the legal services provided by CAP. CAP also represents and educates non-union members on the advantages of being part of a union by representing them in their struggle to receive unemployment benefits and providing resources and information about joining or starting a union. CAP's high success rate leaves an indelible impression on non-union members. CAP knows this because, more often than not, non-union members represented by CAP attorneys often ask how they can join a union, start a union or donate to a union. CAP is committed to upholding the mission of MWC by continuing to provide quality legal services to union and nonunion members.
